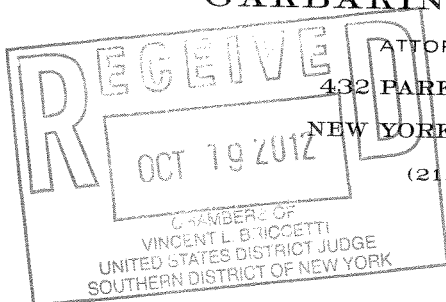

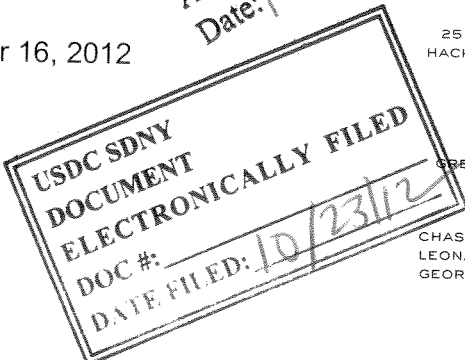

Dear Judge Briccetti:

Our law firm represents defendant Maria Patrizio, Esq. in this action, and are writing to the Court in response to the plaintiff's letter dated October 11, 2012. In that letter, he asks the Court to dismiss our motion to dismiss as well as the motions of several co-defendants on the basis that he needs answers and discovery to respond.

On behalf of Maria Patrizio, Esq., we ask the Court to deny plaintiff's application. Our Pre-Answer Motion to Dismiss is based upon the insufficiency of the Complaint for failure to state a cause of action, as set forth in our motion. It is our position that discovery is not necessary for the Court to reach a determination on this motion.


